

Regular Geneseo Town Board Meeting- Thursday, April 25, 2013

A regular meeting of the Geneseo Town Board was held on Thursday, April 25, 2013 in the conference room of the Geneseo Town Office Facility.

MEETING OPENING, APPROVAL OF MINUTES:

Supervisor Wadsworth called the meeting to order at 7:00 pm. Councilman Taylor the pledge to the flag and a moment of silence was held for our service men and women serving around the world.

The April 11th minutes were reviewed and amended. Mr. Wrubel moved and Mr. Taylor seconded the motion to approve the minutes of April 11, 2013 as amended. Motion passed with voting as follows: Wadsworth-aye; Irwin-aye; Wrubel-aye; Taylor-aye. Nays: None. Mr. Manapol abstained from voting as he was absent from that meeting.

MT. PLEASANT CEMETERY:

The Board reviewed a request from the Mt. Pleasant Cemetery Secretary requesting financial assistance for mowing and maintenance of the cemetery in 2013, if needed. Supervisor Wadsworth advised that \$5000 is budgeted in the 2013 budget for Mt. Pleasant Cemetery. Mr. Wrubel moved and Ms. Irwin seconded the motion to assist Mt. Pleasant Cemetery in an amount up to \$5000 for mowing and maintenance in 2013, if needed. Motion passed with voting as follows: Wadsworth-aye; Wrubel-aye; Irwin-aye; Manapol-aye; Taylor-aye. Nays: None.

CONESUS LAKE/LONG POINT PARK:

The Board reviewed a request from Chuck Doerflinger for permission to rent out and launch kayaks and paddleboards from Long Point Park, as he did last year. Mr. Manapol moved and Ms. Irwin seconded the motion to give permission for Chuck Doerflinger to rent out and launch kayaks and paddleboards from Long Point Park, with the same provisions as in 2012 and meeting requirements of the Town Attorney and Insurance Agent. Motion passed with voting as follows: Wadsworth-aye; Manapol-aye; Irwin-aye; Wrubel-aye; Taylor-aye. Nays: None.

The Board reviewed Deputy Supervisor Irwin's recommendations for the hiring of lifeguards, lifeguard pay and hours of beach operation at Long Point Park. After discussion, Ms. Irwin moved and Mr. Taylor seconded the motion to hire the following lifeguards for the 2013 summer season:

\$40,366.98. He indicated that the premium has increased, due to additional vehicle(s) and budget expenditures.

Mr. Chanler reported that NYMIR did an appraisal of the town's real property to establish insurable values. There was an increase in property values, some at 4% due to an increase in cost to replace the item, and some as a result of the appraisal. Mr. Chanler reviewed the values of the items/buildings on the statement of values. NYMIR also performed a Loss Control Survey and, as a result, made recommendations which the town followed through with. Additionally, all Town Highway employees attended a Snow & Ice best practices seminars offered by NYMIR.

One recommendation that Mr. Chanler made is that a fire alarm system and possibly a burglar alarm be installed in the highway garage. The funds for this could be incorporated in the 2014 budget and the alarm(s) installed in 2014.

Mr. Taylor moved and Ms. Irwin seconded the motion to renew the Town's insurance coverage with NYMIR through the Chanler Agency in the amount of \$40,366.98, as proposed. Motion passed with voting from: Wadsworth-aye; Taylor-aye; Irwin-aye; Manapol-aye; Wrubel-aye. Nays: None.

ADJOURNMENT:

At 8:00 PM Mr. Taylor moved and Mr. Wrubel seconded the motion to adjourn the meeting. Motion passed unanimously.
