REGULAR MEETING OPENING& APPROVAL OF MINUTES:

Supervisor Wadsworth called the regular meeting to order at 7:00 pm. Councilman Manapol led the pledge to the flag. A moment of silence was held for service men and women serving around the world.

CONESUS LAKE/LONG POINT PARK:

Supervisor Wadsworth asked the board members for their thoughts on the creation of a **master plan** for Long Point Park. This plan would outline what the Town Board thinks the park should be. Supervisor Wadsworth continued to state that this plan will allow for revisions as time progresses. Ms. LaVigne recommended that the plan should detail what can legally be accomplished in the park.
