1. **Call to Order:**

Patti LaVigne (Comprehensive Master Plan) reported that the map is being re-formulated.

4. **Code Office Report and Other Business:**

The list of Town Building Permits (and other permit information) for the period 09/01/08 – 11/30/08 was received by the Planning Board but not discussed.

5. **New/Other Business:**
