

LONG POINT PARK & PAVILION RULES AND REGULATIONS*

Carry In and Carry Out Rule - All items brought into the park by users shall be removed by those users.

Any Rules and Regulations that require Town Board approval must be done at least one month in advance of the event.

Violation of any of the rules and regulations may result in a citation, fine and/or removal from the park.

Long Point Park & Pavilion Rules and Regulations:

- Park Hours are from 8:00 a.m. – 10:00 p.m.
- Smoking is permitted in designated area only.
- No parking on the grass.
- Pets must be kept on a leash and are not allowed to enter the water. Please pick up after your pets.
- Pavilion use is on a first come-first serve basis unless reserved through the Town of Geneseo.

Long Point Park & Pavilion Rules Prohibit:

1. Disturbing the peace.
2. Dangerous weapons and firearms.
3. Drugs, illegal substances and vandalism (criminal offense).
4. Sale and/or abuse of alcohol in the park.
5. Solicitation or peddling.
6. Leaving personal property unattended.
7. Harass, hunt or and trap animals within the park.
8. Damage to the park grounds, facility and pavilion.
9. Overnight in parking lot and entering the park outside of normal hours of operation.
10. Cook in any area not designated for that purpose including picnic tables and grass.

Require Approval from the Geneseo Town Board:

- Sign, banner, advertisement, or notice of any sort within the park.
- Use of motorized vehicles within the park including mopeds and golf carts.
- Tents, amusement devices, rides, mechanical devices or games, inflatable bounce houses, and trampolines.
- Overnight docking purposes.
- For organizations and businesses requesting use of Long Point Park (including the Pavilion) a current Certificate of Insurance is required and should contain the following information:
 1. Insurance company name, policy number, policy dates, etc. for any/all policies Applicable (i.e. General Liability, Business Auto, Umbrella, Workers Compensation, etc.).
 2. The certificate must include the town of Geneseo listed as an additional insured for Liability Coverage.
 3. Include Business Auto, Umbrella, and Workers Compensation coverage if applicable.
 4. The General Liability coverage must show limits of at least \$1,000,000 per occurrence.
 5. Under Description of Operations Section, please include a brief description and include all dates the park is being used (i.e. use of Long Point Park for office picnic on August 1 & 2 which includes set-up and tear down dates).
 6. The Certificate of Insurance shall be received by the Town Clerk's Office no later than four (4) business days in advance of your event at the park.
