Application for Short-Term Rental Permit

Instructions Page (Please do not turn in this page with your application.)

- 1. Upon approval of the Application, the Code Enforcement Officer will issue a Short-Term Rental Permit to the applicant. The Permit shall be kept on the premises. In the event a permit is declined, you will be contacted.
- 2. No property shall be rented until a Permit has been provided.
- 3. Permits expire on December 31st of the date of issue calendar year.
- 4. The number guests permitted overnight at the short-term rental property is limited to two guests per bedroom plus two guests. The Town of Geneseo's assessment records shall be the final determination on the number of bedrooms.
- 5. The number of vehicles permitted overnight at the short-term rental property is limited to the number of designated parking spaces on the property. Designated parking spaces shall be on an improved surface, on the rental property, not part of a shared driveway or other shared access easement, and adhere to the minimum size of parking spaces, and other applicable requirements in Article 41 of the Town Code. On-street parking is strictly forbidden on town roads.
